WELCOME ARTIST

The Art Center invites you to apply to participate in The Art Center of Western Colorado (TAC) Native American Art Market. The Fair is a lively event that features two days of sales and an evening presentation by Mark Winter of Toadlena Trading Post.

ELIGIBILITY

The Market is a fully juried event. It is open to all artists selling their handmade items. Absolutely no manufactured, mass-produced, or commercial items are allowed. We reserve the right to remove any item determined not to have been handmade by the exhibitor or any work that differs greatly from the submitted images. All media will be considered. Preference will be given to artists with Native heritage.

BOOTH SPACE

- An **8'x 6' space**, one table (**if requested**), and two chairs (**if requested**) will be furnished per booth rental space. **Vendors should bring their own tape, tools, extension cords, electrical power strips, and any extra lighting.** Please note: **Vendors may not expand beyond their booth space.**
- All display and sales materials are the responsibility of the vendor. Vendors will be allowed to bring display materials as long as they do not impose upon neighboring booths. Within reason, items may be taped to the walls.
- Booth set-up is from 9 am to noon on Friday, November 14. **Vendors are to be open for business by Noon.**
- Booths may not be dismantled before 3:00 pm, Saturday, November 15. The Art Center has security; however, artists may want to remove unusually valuable work overnight.
- Please note: **TAC provides general lighting only!** It is impossible to accommodate all vendor's lighting needs. It is **highly** recommended that **vendors bring lighting** to illuminate their booths and products. Power will be provided to each booth (**if requested**).

HOW TO APPLY

- Please submit the following items:
 - A **completed** application (application on the third page)
 - Applications may be filled out digitally and emailed or filled out on paper and mailed in.
 - Up to four digital images of your work:
 - Flash drives, CDs, Emails, and links from WeTransfer, and Google Drive accepted
 - All images must be high resolution in .jpg format
 - All images must not exceed 3 MB in size
 - **All images must be labeled as follows:**
Last Name_First Name_Title or Type of Work.
For Example: Doe Jane_Sunset on Mt. Everest.
Note: If your title has more than one word, simply leave a space in between each word as you would in writing.
 - **Booth Fee: FREE.**
Since this is the inaugural year (and thanks to our sponsor), the Booth Fee has been waived.

SALES INFORMATION

- You are participating in and supporting a **fundraiser for TAC**. Each vendor remits **10% of gross receipts to The Art Center by 5 pm Saturday**.
- Insurance and taxes are the responsibility of the vendor. Each seller must collect a total of 8.66% sales tax (3.39% City, 2.37% County, 2.9% State) from buyers and remit the tax to the Colorado Department of Revenue. **Each vendor must have his or her own sales tax license.**

PARKING

Vendors may load and unload at the front of the building and through Studio Colorado at the rear of the building.
